Rawalpindi, the 10th December, 2015

S.R.O. 1264(I)/2015.—The following draft Bye-laws, to regulate parking of vehicles in limits of Karachi Cantonment, are proposed to be made by Karachi Cantonment Board, in exercise of the powers conferred by clauses (25), (26) and (39) of section 282 of the Cantonments Act, 1924 (II of 1924), are hereby published for information of all persons likely to be affected thereby and, as required by sub-section (1) of section 284 of the said Act, notice is hereby given that any objections or suggestions in this regard may be sent within thirty days of the publication of this notification.

Any objection or suggestion which may be received from any person, before the expiry of the said period, shall be considered by the Karachi Cantonment Board, namely:—

DRAFT BYE-LAWS

1. **Short title and commencement.**—(1) These Bye-laws may be called the Karachi Cantonment Board (Parking of Vehicles) Bye-laws, 2015.

(2) They shall come into force at once.

2. **Definitions.**—(1) Unless there is anything repugnant in the subject or context,—

(a) “Act” means the Cantonments Act, 1924 (II of 1924);

(b) “authorized place” includes a road, street, ground and open space where the Board authorizes parking;

(c) “book” means the book of receipts which are issued to the individual parking a vehicle at the authorized place;

(d) “contractor” means a licensee who is authorized to collect parking fees on behalf of the Board; and

(e) “parking” means stationing a vehicle for a specified time at authorized place.

(2) All words, phrases and expressions used but not defined in these Bye-laws, shall have the same meaning as is assigned to them in the Act.

3. **Terms and conditions of parking, its fee etc.**—(1) No person shall park his vehicle in any place other than the authorized place in Karachi Cantonment, provided that this Bye-law shall not apply to the residential and commercial buildings having specifically reserved areas to be used for parking, as approved in the relevant building plan.

(2) Any person who intends to park his vehicle at the authorized place shall pay to the Karachi Cantonment or its licensee, a fee as specified and in column (3) of the Table below, applicable to the vehicle specified in column (2) thereof, namely:—

1.	Bus, Coach, Truck, etc. (HTV)	40/
2.	Car, Jeep, Taxi, Pickup, etc. (LTV)	20/
3.	Motorcycle, Scooter, rickshaw, etc.	10/

- (3) The Karachi Cantonment Board may approve a general scheme of parking of vehicle wherein the positioning of vehicles and numbers of rows may be determined.
- (4) The Karachi Cantonment Board may charge the fee to be collected from the person parking his vehicle at authorized place either through servants of Cantonment Board or through a licensee.
- (5) The Karachi Cantonment Board may award the rights to collect the parking fee to a licensee who offers highest bid and such award shall be for a term of one year only.
- (6) The Karachi Cantonment Board may enter into a contract with the licensee and the terms of contract shall be binding on both the parties.
- (7) The licensee shall collect the fees on receipts book prescribed at Annexure to these Bye-laws, counterfoil whereof shall be deposited with the Karachi Cantonment Board on expiry or earlier termination of the contract.
- (8) The licensee shall collect prescribed fee and issue receipt from the receipts book.
- (9) Vehicles of the Federal Government, a Provincial Government, Armed Forces and Cantonment Boards shall not be liable to pay parking fees.
- (10) The Karachi Cantonment Board shall, subject to the provisions of the Act, be authorized to invoke penalty clauses of the contract agreement with the contractor to ensure that the licensee charges only prescribed fees, and does not violate the scheme of parking approved under sub- bye-law (2).
- (11) Any person contravening any provision of these Bye-laws shall, on conviction, be punishable with fine which may extend to one hundred rupees and, in the case of continuing contravention, with an additional fine which may extend to twenty rupees for every day during which such contravention continues after conviction for the first such contravention.
